

Remarks Ms. S. Ali McIntosh, BCP Servant Leader On the Occasion of the BCP Re-Launch - November 22nd 2016

I would like to express my thanks to the entire BCP Board, whose belief in the vision inspires me. The chairman – Demetrius Frazier; Aaron Cox; Carol Thompson... Dr Jane white; and the entire team. The candidates we have ratified, and those we are still considering.

On the 29th of August, the BCP suspended its campaign for an indefinite period, after prayerful consideration by its leadership. This was to allow us to evaluate and reflect our position, and our viability in the campaign for the governance of the nation. This time

was also to allow the nation an opportunity to determine, whether the voice and narrative of a BCP agenda, brings value to the table regarding the building of the nation.

While all our candidates continued their personal campaign on the ground, we discontinued all talk shows and public statements; giving the opportunity to hear the direction of God for the campaign, going forward; And to build a stronger team undisturbed by the abundance of shenanigans that we have been bombarded with from the other political parties; in many instances, desperate persons seeking to gain momentum and validity at our expense.

The strategy to Retreat and Reorganize have been primarily successful, which is why we have returned to forward the BCP agenda for Righteous Governance all the way to the polling day.

The BCP determination to educate the populace on values necessary for good governance and a more transparent standard of leadership; is certainly what the people are indeed ready for, and has placed these demands before the leadership of the government – and have sought their answers in a few days.

Today, is only the introduction to a new BCP reorganized focus, new restructured team, and a fresh, honest look at the BCP Agenda and the leaders we engage; as substantive Hope for the salvation and reclamation of the entire Bahamian society.

BCP is Hope for Bahamaland.

This partnership that we announce today during this Re-Launch of our campaign, speaks to this agenda as not 'Politics as Usual'. This kind of political maneuvers brings to bear leadership from a Biblical perspective — an apostolic model, with the inspiration of each sector of society contributing to the service to God's people — with the ideals of both the Prophet, Priest and King. No, we are not going back to biblical days, but we are admonished to return to Biblical Morality.

The People's Foundation (1996–21yrs) & the Bahamas In Prophecy (1998 -18yrs) have sought to partner towards the implementation of Righteous governance, is in congruence with each other. We have found common ground regarding the need and timing for Righteous principles in the governance in the nation.

You wish to ask, What is Righteous Government? What does that mean?

Righteous Governance is also call Good Governance. It is doing the Right thing, for the right People, all the time. It is accountable, Transparent principles of governance, with service to the people above the organization or selfish individuals own agenda.

Righteous governance facilitate the people's need, and their right to be informed, and advised, on what is best for them in the process. Righteous governance is protecting the people's Inheritance at all costs; and protecting the sovereignty of the state.

The agenda of a Righteous government will make abundant opportunities for its citizens, and attempt to make wealth common for the masses, and not a free market economy that favours the rich and wealthy over the poor.

This matter of a righteous governance was first forecasted by Sir Lynden Pindling and Sir Randol Fawkes back in 1956, when they penned a letter to their constituents articulating their desire to implement it in the Bahamas. And certainly in the days leading up to their Majority Role victory in 1967, and Election 1973, their desires continued.

This is the reason that Preamble, was placed in the Constitution of the Bahamas.

Preamble

Whereas Four hundred and eighty-one years ago the rediscovery of this Family of Islands, Rocks and Cays heralded the rebirth of the New World;

And Whereas the People of this Family of Islands recognizing that the preservation of their Freedom will be guaranteed by a national commitment to **Self-discipline**, **Industry**, **Loyalty**, **Unity and an abiding respect for Christian values and the Rule of Law**;

Now Know Ye Therefore:

We the Inheritors of and Successors to this Family of Islands, recognizing the Supremacy of God and believing in the Fundamental Rights and Freedoms of the Individual, Do Hereby Proclaim in Solemn Praise the Establishment of a Free and Democratic Sovereign Nation founded on Spiritual Values and in which no Man, Woman or Child shall ever be Slave or Bondsman to anyone or their Labour exploited or their Lives frustrated by deprivation, and do Hereby Provide by these Articles for the indivisible Unity and Creation

Preamble Promise

- 1. That the government will govern by these core values. (See Preamble) Recognizing that the "Preservation of the Nation's Freedom depends on it."
- 2. That the government will ensure, that
 - a) That the people will not be enslaved or bondsmen to anyone,
 - b) That their Labour will not be Exploited by anyone,
 - c) That their lives will not be frustrated by Deprivation.

To Ensure that the citizens of this Bahamaland is protected from **Enslavement**, **Exploitation**, **Frustration and Deprivation** - is the primary commitment of Righteous Governance. This is a promise envisioned by the Founding Fathers...and It is a Promise a BCP Government must keep.

The two years from 1998 prior to death of both Sir Lynden and Sir Randol, I received significant mentorship from them both.

Both men encouraged me to continue to forecast this vision for the return of the people to a kind of government they envisioned and projected.

In 1998, I received a divine revelation, and instruction to begin a political organization for the return of the Bahamian people back to Righteous governance. The three instructions of which I have diligently defended were:-

- a) Run 39 candidates under the banner of the Bahamas Constitutiton
- b) Ask Christian men and women to make themselves available to serve,
- c) And go to Sir Lynden, and exact from him the Original intent of the Preamble of the Constitution.

Therefore, in my approach to Sir Lynden over the term, he did not only encouraged me to persist; but insisted that this BCP agenda was the only way to get back to the point, and kind of governance they intended the create.

He insisted that he and the PLP had failed their mission to realize their original intention by the Preamble Promise; And that, the FNM was taking the country in a further Liberal-Secular stance. He advised that if I can find 10 persons who will stand with me, I must continue to pursue this agenda.

This has been my pursuit over the past 18 years.... And it continues. However, now there is more than 10 persons who believes, and stand with me to place this agenda to the

nation, in a Re-Newed Mandate; Re-Organized Team and Re-Energized Pursuit. Thus this partnership with BIP & TPF.

Many persons in this political arena has attempted to **Re-Name and Mimic** an agenda that has stood the test of time, to bring purity and authentic leadership to the Bahamian people. Because, the implementation of Righteous governance in the Bahamas cannot come about by unrighteous acts, but by an original Vision, an authentic people, or a reformed mandate for governance. There are many who attempt to speak for Righteous governance in a vain attempt to hardness a growing popular message whose time has come.

I wish to declare that 'It is the time for Righteous Governance, and we are the people who will bring it forward. There is a slogan of the BCP that says, "The People have a choice to vote, But God has a Plan. The BCP has that plan.

This is just the beginning, of a New BCP with a National Mandate for the New Bahamas. As our message spreads, our team will grow. And as out team grow, we will indeed complete our mandate to place 39 men and women on the ballot in 2017.

It is our only mandate...And it will be our primary pursuit.

In this regard, in 2011, the Lord told me, that,

"The BCP is my Hope for Bahamaland, Because No one will take this agenda this far. And if you can find 39 men and women for this agenda, I will give you a new Bahamas. Then he said, 'Tell the Bahamian people, they will only have one chance to choose the Cross.'

While I was baffled by the soberness of that word in 2011; as I look at the political landscape, where over the past administration of the PLP and the FNM, has brought the Bahamas under Economic Suppression to Foreign Direct Investments, and is now on its way to full Colonization by the People's Republic of China; I know that it was a true word for this time, and this people.

While both the Ingraham and Christie's Administration has facilitated over the past 25 years, chunk by chunk the ownership of the Bahamas to the Foreign element, only a party that is for the People, By The People, with a heart for the people, will rescue the nation for generations yet unborn.

The Bahamas Constitution Party is the People's Party.....We are the People's Servants. We have sacrificed, we have waited, we have spent the time to see the fruition of God's agenda for the Bahamian people. A free people in this Bahamaland - Where the road we trod leads unto our God – #WEMarch on Bahamaland.

Our Parents fought for our freedom from under Colonialization, so that they could be a free people; and now, merely one generation later, the freedom and economic existence of our children, is being threatened by subsequent administrations that have lost sight of the Founding Fathers original intent in governance, to continue to secure the Bahamas for Bahamians.

We are living in a week, where the PLP are identifying the FNM's deals with the Chinese; and the FNM is talking about the Chinese deals with PLP. However, both governments are compromised regarding the outsourcing of the Bahamian people's resources to the Foreign element.

This is the time when the People must Stand up for themselves against a Status Quo that has continuously neglect the people's agenda.

As a Party, the BCP will stand against this full agenda of both the PLP and the FNM to disenfranchised Bahamians, particularly with the People's Republic of China.

As a party, the BCP will demand that the government cease all deals with the People's Republic of China for any further investments. At this late stage in their term, all such deals should be taken off the table. **Notwithstanding, the PM statement last night...the people must still Stand...And still #WEMarch.**

As a Party, the BCP will place on the table of the HOA a Freedom of Information Act within the first session, that comes with a government committed to Accountability and Transparency. Only a Righteous Agenda will be committed to this level of Integrity to do the people's business.

As a party, we now demand, as the people do also demand, that A DATE FOR GENERAL ELECTIONS IS SET FORTHWITH. It is despicable that 167 days from a Constitutional mandate for General Elections, and this PLP — Christie administration has not seen fit to warn the country, the day designated for General elections, as if our schedules does not matter in the light of their planned shenanigans.

As you now know, the BCP is a proactive group, seeking to place forward policy and proposal even though it is not yet elected to governance.

1. The BCP has participated and assisted other civil society organizations to defeat both constitutional referendums, in 2002, and 2016.

- 2. The BCP went to Court on June 6th 2016 to challenge the right of the No-Vote to monitor the polling at the Constitutional referendum.
- 3. The BCP recently presented a proposed Legislation to the HOA Speaker & Constituencies Boundaries Commission, Dr. Kendal Major that related to the Suppression of Registration of Voters.

And in this proactive approach, the BCP has began preliminary ground work to seek "An Observatory Team from the Organization of American States (OAS) to observe the upcoming General Elections. This approach is necessary, because we do not believe, given the level of corruption in the government, that a fair General elections will be held.

It is also our view, that because of the high level of request for Chinese investments in the country, and the fact that the people cannot get an accurate reporting of the details, the influence of the PRC and its funding, will affect the election greatly.

I am therefore calling on the government to seek the approval of an Observatory Mission for the General Elections. As the BCP will continue its pursuit to Lobby the OAS to request permission to come and observe.

In closing,

The Bahamas Constitution party seeks people whose heart is only for the Bahamian people. We will not take the root of Status Quo to get only Lawyers and Doctors and Accountants as candidates for Parliament, we wish to appeal first to the heart of men and women, who believe that they can represent the people and look after the people's interest first – persons who can be the People's Servant – Servant Leaders.

We are seeking person, who has the intellectual capacity to hear the voice of the people, to feel the need of the People, and to Do the bidding of the people.

We seek your assistance, and your permission to represent the BCP on the ballot. The ballot and the symbol which stands for Hope, Salvation and Redemption of the People's agenda – The Cross.

As we go into the next 167 days, we continue to move forward with Hope, with perseverance and a Heart for the People's agenda. The BCP is the People's Party. The BCP is Hope for Bahamaland. The People have a choice to choose whatever party they wish... But God have a plan for this Bahamaland.
